Dear Client:

At SunTrust, we continuously monitor our clients' accounts to protect not only their interests, but also SunTrust's interest. With that said, we regret to inform you that due to information obtained during our review of your account(s), we have determined that it is necessary to close your account relationship.

Your deposit accounts with SunTrust are governed by the *Rules and Regulations for Deposit Accounts*, a copy of which was provided to you at account opening and is available on suntrust.com. The Rules state, "We may at any time in our discretion, refuse to open an Account, refuse any deposit, limit the amount which may be deposited, return all or any part of a deposit or close the Account without advance notice to the Depositor."

This closing affects your deposit accounts, safe deposit boxes and SunTrust credit cards. Your deposit accounts will be closed on **April 18, 2019.** At that time, we will either mail you a check to the address we have on record for any collected and available balances or hold the funds until we hear from you. As a reminder, you remain responsible for any fees on items presented against your account(s), as well as outstanding checks and overdraft balances. Please know that you have the option of closing the account(s) prior the scheduled closing date noted above.

In preparation for the closing of your account(s), you should begin to make alternate arrangements for any automated credits to, or debits from, your accounts. In addition, you may be prohibited from making any deposits into your account(s). If you have a SunTrust Debit Card, it will become inactive within 10 calendar days of the date of this letter. Further, all related deposits or account services you may have, including Online Banking, Bill Pay, Treasury Management Products and Overdraft Protection, will also be discontinued at the time your account(s) is closed.

If you maintain a credit card with the bank, you will receive a separate communication detailing any applicable account closure information. This account closure <u>does not include</u> any of your installment loans, home equity loans/lines (or a credit card attached to a home equity line), term commercial loans, mortgages, or IRA accounts. The original terms and conditions of these products will remain in effect until maturity. If applicable, any of your Certificates of Deposit (CDs) may remain until the current maturity date. Your CDs will be set to not automatically renew. An early closure may result in penalties.
