#### FROM THE EDITOR

elcome to the first edition of the California Cannabis Business Licensing Guidebook. California's legal marijuana market, which relaunched in 2018 under a new statewide framework, has a crucial caveat that led to the creation of this report: Local authorities are the true gatekeepers of the industry.

That's because, in order for any plant-touching company to get a state license with which to deal in marijuana, that company must first obtain local approval.

Local governments also have the power to layer on more regulations—and fees—for businesses, up to and often including total bans on all types of cannabis companies.

The power wielded by local governments has led to the oft-lamented fact that only about one-third of the municipalities and counties in the entire state of California have opted into the marijuana program.

This framework also has led to a wide patchwork of rules, making California a maze for anyone new to the industry or out-of-state operators looking to expand into California. Some cities allow for every type of marijuana company available for both medical and recreational cannabis businesses. Others allow only testing labs. Some allow only cultivation. And some allow only medical marijuana companies, not adult use.

But the one-third number is slowly but steadily changing, with more business licenses going up for grabs as time goes on. The reason for that is multifold, but a major driver in 2020 has been the recession and government tax shortfalls. As local and state officials have been looking for ways to shore up their tax revenues, many have become more open to the idea of allowing the seemingly recession-proof marijuana industry to gain more of a legal foothold across California.

The cannabis industry landscape in California will continue to evolve for years to come. And the rules that do exist will most certainly change, as will the dynamics of each market. Los Angeles, for example, still has hundreds of marijuana business licenses to issue.

For that reason, this guide is only the first iteration.

This guidebook is intended to give you the tools to find your way through the California regulatory maze in order to compare business opportunities in various cities and counties and learn what you need to know to get started there. This includes details on:

- · What types of businesses are allowed.
- Costs associated with starting and operating a cannabis business in key markets.
- How many businesses of each type are allowed—and how many are already operating.
- Changes being considered by the local agencies overseeing the industry.



# STATE REGULATION, LICENSING AND FEE OVERVIEW

California is easily the most complex state in the nation when it comes to navigating marijuana business licensing.

For one thing, there are currently three separate state agencies that oversee different business types:

- The Department of Food and Agriculture (CDFA) oversees all cultivation.
- The Department of Public Health (CDPH) oversees all manufacturers and edibles makers.
- The Bureau of Cannabis Control (BCC)—a wing of the larger Department of Consumer Affairs—oversees every other business type, including retailers, delivery operations, distributors, microbusinesses, testing labs and events.

There are also a whopping 18 different marijuana business licenses for entrepreneurs to choose from, including 10 separate cultivation permits.

License types include:

Fees also run the gamut.

For instance, a specialty cottage outdoor cultivation operation license—the smallest and cheapest available for craft growers—costs \$135 to apply and \$1,205 for the annual permit. By contrast, the most expensive cultivation permit, a medium indoor license, runs \$8,655 just to apply and \$77,905 for annual renewal.

("Large" cultivation licenses won't be issued by the state until 2023, but many commercial operators get around that through license stacking, or obtaining multiple cultivation permits for the same facility, to expand the square footage of canopy for growing.)

Fees for business types through the Bureau of Cannabis Control also vary widely and are usually dependent on the company's estimated annual gross revenue. For example, a retailer expecting to gross \$500,000 or less will pay only \$2,500 for an annual license fee, but a retailer that projects more than \$7.5 million in revenues will see that license fee jump to \$96,000. License fees can easily reach six figures for microbusinesses and distributors particularly.

The above links likely will change in 2021, because Gov. Gavin Newsom has pledged that the three regulatory agencies will be merged at some point. Newsom wants to create a singular regulatory body for the entire marijuana industry—the Department of Cannabis Control.

The current three regulatory agencies rolled out a new license database in September 2020 to house all marijuana licensees. Previously, each agency had its own database of licensed companies.
